VISA FOR JOB SEARCH OPPORTUNITY CARD (long-term visa)

Only by appointment booked online on our website at www.ramallah.diplo.de/appointments

If you have a <u>university degree that is recognized in Germany</u>, you can be granted a residence permit in the form of the Opportunity Card for the purpose of looking for a job that your qualifications enable you to carry out, or for the recognition of your qualification.

Prerequisites for the job search visa are:

- Academic diploma, recognized in Germany (proof required)

AND

- Living expenses are secured (1091 EUR per month, through a blocked account or formal obligation from Germany)

If you do <u>not have a recognized university degree</u>, you can also be issued a residence permit in the form of an Opportunity Card in order to seek measures to have your foreign professional qualifications recognized.

Requirements are:

1.1 You have a professional qualification that is recognized in the Palestinian territories and which required a training period of at least two years (must be confirmed by the Central Office for Foreign Education, 'Zentralstelle für ausländisches Bildungswesen'),

OR

1.2 You have a university degree that is recognized in the Palestinian territories (but not in Germany) (must be confirmed by the Central Office for Foreign Education, 'Zentralstelle für ausländisches Bildungswesen')

OR

1.3 You have a so-called AHK qualification.

AND

2. Proof of language proficiency: You either have <u>German</u> language skills of at least level A1 as defined by the Common European Framework of Reference for Languages (CEFR, proof via Zertifikat A1 from Goethe-Institute, no older than six months) or <u>English</u> language skills of at least level B2 (CEFR) (TOEFL, IELTS, no older than six months).

3. You must achieve at least six points in the points system

AND

4. Living expenses are secured (1091 EUR per month, through a blocked account or formal obligation from Germany).

The visa as an Opportunity Card is issued for up to one year. It can only be issued again if the foreigner has stayed abroad for at least as long after leaving the country as he previously stayed in Germany on the basis of an Opportunity Card.
